SPECIAL CONDITIONS FOR THE ACCOMMODATION OF TRAVEL BUBBLES IN ESTABLISHMENTS WITH MULTIPLE OCCUPANCY ROOMS

- 1.- The above-mentioned persons are making a joint trip, living together as a Travel Bubble during the trip.
- 2.- A Travel Bubble of travellers will be considered to be a stable group of people who are going to live together, mainly mixing with each other during the days of their trip, and whose members undertake to minimise interaction with other people outside the group, and in the event of such interaction, this will always be done in strict compliance with the current Covid-19 health prevention regulations. - 3.- The declaration that they form part of a Travel Bubble will be made by its members, and will entitle them to be accommodated in multiple occupancy rooms in the accommodation establishments that have them, and they may occupy these rooms without taking into account the capacity limit allowed for non-cohabitants, as long as no person from outside the group or belonging to a different Travel Bubble is accommodated in these rooms.
- 4.- The members of the duly constituted Travel Bubble agree to be considered as cohabitants for the purpose of using the facilities of the accommodation and catering establishments.
- 5.- Concealing information or making inaccurate declarations will give rise to possible liability before the HEALTH AUTHORITIES and before the HOSTEL or HOSTELS that have provided the accommodation.
- 6.- Neither the person in charge of the group, nor any of the persons mentioned have symptoms compatible with COVID-19, nor any other infectious or contagious disease at the time of the start of the trip as a whole.
- 7.- The above signatories express their wish to be considered as cohabitants for the purpose of being accommodated in single, double and multiple occupancy rooms, even if the capacity of these rooms exceeds the capacity foreseen by the health authorities for non-cohabitants, and even if the distances between beds may be less than those recommended by the said authorities in the case of non-cohabitants.
- 8.- The Hostel may provide joint accommodation for the Travel Bubble as long as this possibility is provided for in the legislation in force.
- 9.- Each and every member of the group declares to have received sufficient information on the preventive measures to be adopted to avoid the spread of COVID-19, and undertakes to adopt and follow them for the duration of their stay at the Hostel.
- 10.- Each and every member of the Travel Bubble undertakes to inform the HOSTEL, and the health authorities, if any of its members have symptoms compatible with COVID, are found positive in a COVID detection test, or are diagnosed with COVID within 21 days of the end of their stay in the HOSTEL.
- 11.- By signing this document, each and every one of the members of the group exonerates the provider company from liability in the event of infection originating and coming from another member of the group.
